- c. Updates from Cities Commissioner Suza Francina requested that Staff investigate housing discrimination and report back to the Commission on their findings. The Cities shared their efforts to educate their residents and how they are supporting Animal Services work in keeping costs down. Staff was instructed to place the Spay/Neuter ordinance on the next commission agenda for discussion. Staff was instructed to research the legalities of modifying the county ordinance regarding rescues to restrict them bringing in animals from outside the County of Ventura and place report on agenda. A list of rescues that are rescuing out of county was requested by the City of Ventura.

Supervisor Bennett suggested placing the "No-kill" discussion on the commission agenda after the City Manager working group researches costs and other options.

Commissioner Carmen Ramirez requested an evaluation of the shelter to show how changes made at shelter have affected costs and adoptions.

Staff was directed to make future commission meetings limited to 90 minutes.
