# 9. Director's Report:

- **a.** Shelter/Animal Care Services at VCAS continue to operate under the same guidelines they have been following for the past several months. All services are still being conducted at the Camarillo Shelter and the Simi Shelter remains closed at this time.
- b. A draft of proposed changes to the VCAS ordinance has been submitted to County Counsel for review. VCAS is awaiting County Counsel's review/comments and will be sharing with select VCAS staff for their input. Once there is a final draft, VCAS will be submitting to the BOS for their review and approval to hold public reading sessions.
- **c.** VCAS submitted a grant proposal to PETCO Foundation for \$50,000 on 8/27/20 to enhance our Pet Retention Program. A grant has also been submitted with the California Department of Food and Agriculture—Pet Lover's License Program to assist with VCAS' Spay/Neuter enforcement efforts.
- **d.** Final enhancements are still being made to VCAS' new website.
- e. VCAS is currently working on the 2020 Annual Report. A brief overview of the preliminary data was shared.

- a. Commissioner Gama shared that a baby whale was seen in Channel Islands Harbor this week and that it could be viewed on Facebook. He reminded that taking care of our environment will allow more of these sights.
